Is there any progress on The Old Chapel? Cllr. Ryves stated this is still with enforcement who are in contact with the Owner. Cock Corner grass needs cutting JM to check site and will chase this up. Street cleaning – when will this be done?

- Matters arising from the last minutes-Since the lockdown there has been an increase in Owners not picking up after their dogs, he Borough Council have visited and put up additional signs, these have been reported as being removed? More signs have been put up in Ventura Close through to Trent VC Close. Dog mess has been reported on the recreation ground, a reminder that dogs are not allowed on here by order of the Borough Council. A note will be put in the Methwold Times asking people to clear up after their dogs. Owners can double bag it and take it home where they can put it in their black bin if they are not near one of the dog bins.
  - Speedwatch The Police are out doing speed checks, it was reported that traffic seems to be travelling faster especially through the villages, can we ask the Police to bring the safety camera to the parish to

monitor the traffic? Are there specific times when traffic speed seems to be worse, please let the Clerk know so the Police can be informed?

- 8.2 To receive planning applications
- 20/00597/F Retrospective application for partial demolition of redundant outbuilding at Lancaster Park Farm Globe Street Methwold Thetford Norfolk IP26 4PQ The applicant was given the opportunity to explain the retrospective planning application. The parish council discussed the application and stated that they found it annoying and very depressing that this application has been made retrospectively, the pc can see the benefit of the work carried out but object because the application should have been made and a decision given before work started, it was also felt that the drawings are inaccurate, implying that a part of a building had already been demolished, and land belonging to the parish council has been included as part of the land owned by the applicant, the plans should be accurate. S Burbridge proposed that the application was supported but with the previous comments included, S Crump seconded, Methwold Parish Council voted to SUPPORT application.

It was suggested that a meeting is arranged for the Chairman and Owner to study the deeds and to discuss and try to resolve historic boundary and access issues when we are able meet in person.

2020-05-15 CONSULT ON NEW NAME Development at Land South of Herbert Drive Methwold – The Clerk had been copied into one comment which was sent to the Borough Council by a resident. The original document was posted on Methwold Parish Council Facebook by the Clerk for information only, the several village Facebook pages are not monitored by the parish council and is used only as a tool to get information and notices out to the residents, especially during the current COVID-19 pandemic.

There is a set of rules set down by the Borough Council which need to be followed when naming property/streets/developments etc.

Methwold Parish Council discussed the name choices of the Developer, these are historical to the village and it was felt that the Developer had done research to come up with this choice of names. P Crawley proposed to accept the three names chosen by the Developer as listed, S Crump seconded – APPROVED.
