- 2. SMALL HEADSTONES in the GARDEN OF REST to be NO GREATER than 457mm X 381mm X 51mm.
- 3. TABLETS in the GARDEN OF REST or ON A GRAVE to be NO GREATER than 381mm X 381mm.
- 4. ALL MEMORIALS/HEADSTONES to be erected AT THE HEAD OF THE GRAVE. When family members have ADJACENT GRAVES the MEMORIAL/HEADSTONE MUST NOT STRADDLE THE PATHWAY between those graves.
- 5. This Application Form must be completed IN FULL and The APPROPRIATE FEE ENCLOSED and Ireturned to The CLERK of The PARISH COUNCIL (Address Below)
- 6. NO MEMORIAL/TABLET is to be erected until APPROVED by METHWOLD PARISH COUNCIL.
- 7. APPROVAL for any MEMORIAL/HEADSTONE will only be given after consideration of HEALTH & SAFETY
- 8. THE NAME OF THE COMPANY/FIRM SUPPLYING AND ERECTING THE MEMORIAL MAY BE CUT IN LETTERING NOT EXCEEDING HALF AN INCH (12.5MM) ON THE REV ERSE SIDE OF THE MEMORIAL
- 9. THE PLOT NUMBER SHALL BE ENGRAVED ON THE SIDE OF THE MEMORIAL NOT EXCEEDING PLOT NUMBER CAN BE OBTAINED FROM THE CLERK
