

## **Councillor and Parish Council Update – 8 January 2021**

### **Local Coronavirus figures**

The current local Coronavirus figures can be found on the Government website:

The figures yesterday were:

- For the time period 28/12/2020 to 03/01/2021 the Norfolk seven-day incidence per 100,000 is 508.3, East of England is 800.0 and England is 626.2
- RED incidences are for Breckland with an incidence rate per 100,000 of 508, Broadland 555.9, Great Yarmouth 633.2, King's Lynn and West Norfolk 479.6, North Norfolk 399.7, Norwich 494.4 and South Norfolk 501.9.

As you are all well aware, the government announced a national lockdown on Monday, 4 January, taking effect on 5 January. Several dates have been indicated for how long this will be, from mid-February, through to end of February half-term and even March. ### Vaccinations

The latest information about the government's vaccination programme, which is being led in this area by the Norfolk and Waveney CCG is available on their website <https://www.norfolkandwaveneyccg.nhs.uk/>.

This includes information about the Swaffham and Snettisham vaccination sites which will go live next week to serve the Downham Market southern areas and the Northern coastal areas, in addition to the two already open at St James in King's Lynn and St John's at Terrington St John. There is also a mythbuster about the vaccinations which you may find useful. We have been assured that for those needing assistance with getting to their appointment arrangements have been made with transport providers. The GP practice should ask the question when booking the appointment, but if not, concerned residents should contact their GP if they need help with transport for their booked vaccination appointment.

Please remember the key message is to be patient. The vaccination programme is being rolled out, more sites will become available as supplied of equipment and the vaccine are provided, and people will be dealt with in accordance with the government's priority list. People should wait until they receive an appointment, rather than contacting the hospital or their GP.

### Enhanced contact tracing

We are working proactively with our Public Health colleagues at Norfolk County Council to bring in some enhanced contact tracing that will enable us to provide information and advice about self-isolation to contacts of people who test positive. We will update you further on this in next week's update.

Our team is working tirelessly to process these payments as quickly as possible, but there have been a few delays recently. There are currently around 9 different schemes in place. When they are announced publicly it is some time before we receive guidance, and just before Christmas they came in a flurry. Policies need to be written and the suppliers of our business rates system need to develop new software to enable payment to be made. This then needs to be tested before being placed into our live system.

To update you, tier 2 and 3 grants will be paid by the end of this week. Wherever possible, grants will be paid without an application as we can run reports to establish which businesses are entitled to receive the grant. The grant for wet-led pubs, will be paid early next week.

For the new lockdown grant for closed businesses and the LRSB Closed addendum grant, these are to be combined, which requires some changes to the software which our suppliers are working on but again, we will process these as soon as possible.

If businesses to contact you, please assure them that we are working on it, and will get the payments made as soon as we can, as we do understand the financial pressure they are under.

### **Exercise once a day and stay local**

Local authorities and police are under increasing pressure and scrutiny around travel, but it is important to note that our response is balanced and keeps within the legislation and advice. Local and national media are seeing this as an important narrative and the lack of legislation around it has been flagged to central government.

In the meantime, the police are going to issue the following to back up the stay local message.

*Two people who travelled from Northamptonshire to visit a Norfolk beauty spot have been fined as officers increase enforcement in a bid to support their NHS colleagues.*

*The couple were found to have made the 120-mile plus journey from their home in Wellingborough to visit Horsey to see the seals yesterday (Thursday 7 January 2021).*

*Local officers carrying out patrols approached the couple in the beach car park after vehicle checks revealed it was registered to an address outside of the county.*

*The man and woman, both aged in their 50s, admitted they had travelled to see the seals and were consequently issued with a fixed penalty notice.*

*Officers across the county will be carrying out dedicated COVID-19 patrols in areas such as town centres and beauty spots to make sure people are adhering to the lockdown rules. Officers will stop and speak to people and ask about their reasons for being away from their home address.*

*Temporary Assistant Chief Constable Julie Wwendth, said: "The 'stay at home' rule is clear; you should only leave your home for a reasonable excuse such as food shopping, caring for someone who is vulnerable and for one form of exercise a day. If you do need to leave home for any of these reasons, you should stay local.*

*"The government have outlined that staying local means staying in the village, town or part of the city where you live. It's our responsibility to adhere to this no matter how tempting it is to travel for a change of scene.*

*"Contrary to reports on social media, we are not carrying out roadblocks to check the reasons for people travelling. Officers will use their discretion, as they routinely do in the course of their duties, when dealing with people who have travelled away from their home. We will be proportionate in our approach but if we find people are blatantly breaking the rules, we will issue fines.*

*"We are almost a year into this pandemic; people know the rules and the risks associated with breaking them, so people do not have any excuse for not knowing what is expected."*

If you do have any concerns about individuals not following the guidance, then you should report these via the police 101 number.

### **Homelessness**

The moratorium on landlords evicting tenants from their properties ended in September, however, when serving an eviction notice they had to give tenants 6 months' notice and no evictions could take place. From the 11 January bailiff action can be resumed, meaning that renters can be evicted where appropriate notices have been served. We have been monitoring these changes throughout and will be working with families, individuals and landlords to prevent evictions where possible. We have sought additional funding to help with this prevention work.

### **Letters to residents**

In the next week or two we will be sending a letter to every household in Norfolk reminding them about the rules they need to be following, providing information about how to get help and support and also updating on testing and vaccinations as we receive information from the NHS. Once these letters are finalised, we email you a copy in advance so that you are all informed about what we are sending.

### **Communications**

New materials have been issued by central government and by NCC which we have localised. These are being scheduled into our social media channels and we are updating bus stop posters with the new information regarding national Lockdown.

### **Self-isolation assistance scheme**

If anyone in your patch has tested positive for Covid-19 or has been told to self-isolate, they may be entitled to a support payment. There is an NHS Test and Trace Payment and a Local Council Discretionary Payment, each of £500. If they can't work from home and would lose income due to self-isolation, these payments are intended to help them stay at home by reducing money worries. This has the added benefit of ensuring the self-isolation is happening and people aren't finding a way to go back to work.
