documents, to overcome this other councils have purchased a tablet and internet access for those without this facility, the estimated cost approx. £100 with £10 per month, would council consider this to be a benefit? Cllr. Liddle to look into this further with a demonstration to show it working.

Defibrillator – As part of the community group Cllr. Charlesworth-Smith stepped down for this part of the meeting, Cllr. Liddle proposed Cllr. French as Chair, Cllr. Beukes seconded – AGREED

The Chair explained that at the January meeting a request for a defib to be sited in Brookville was received from a resident, this request was discussed and it was explained that the defibs in Methwold and

Methwold Hythe were purchased by community fundraising and donation from Methwold Community Action Group, ongoing costs were covered by the charity set up by the community group in Methwold Hythe and by MCAG in Methwold.

The pc supports the formation of a community group and feel that a defibrillator in Brookville was a good idea.

The Chair opened up the meeting to the public so that the group from Brookville could speak. A lively debate took place where several issues were discussed including fundraising, location, care and maintenance.

Fundraising – a request has been received for the pc to donate £1000 plus £165 per year to maintain the maintenance contract for the Brookville defib. also, liability insurance for the posts. The Brookville group was asked if they had spoken to MCAG regarding funding? – Not yet

Have the Community group got a permit for going house to house? – the visits were to hand out leaflets for the defib and CPR, it was down to residents if they wished to donate.

The community group were asked if they had put in an application to the Borough Council for funding yet? The pc's Finance Committee will arrange to meet to discuss request but funding a defib was not included in the 2023/24 budget.

The pc was asked to provide a letter to Highways to show support for a defib. in Brookville.

Location – proposal to site a defib on the grass verge near the dog waste bin and post box on the Main Road, this is not within the footpath area, it is very uneven underfoot, unknown if this area belongs to Highways or is privately owned.

The streetlight here is orange and may need to be changed to a bright light to illuminate the defib. Is there a better location in Brookville to site the defib? Suggestion the community group look at the grassed area at the start of The Avenue. A licence will be required wherever the unit/posts are to be sited. Care and maintenance – The community group asked – will the pc agree to take on the responsibility of maintaining and supporting the defib, including the weekly checks to prevent the unit from becoming defunct if the person responsible for the upkeep of the unit moves house? The pc feel that the community needs to own the defib.

Community group asked for the pc to cover the annual funding for all three defibs which are located in the parish.

The spokesperson for Methwold Hythe explained that their defib is checked, maintained, and funded by the charity, they will continue to run this way because fundraising knits the community together. They have a governing document and a process for adding or removing people if required.

The Methwold defib is sited at the fire station, it is checked and maintained by the fire station staff and paid for by MCAG funds.

Concern was voiced that Brookville doesn't receive much for the amount of Precept that is paid by residents. Methwold is the second largest parish in Norfolk and encompasses three villages.

Cllr. Charlesworth-Smith was unwell and had to leave the meeting, it was agreed that Cllr. French continued as Chair.

10. Open Forum for Public Participation

An opportunity to hear from members of the public, Borough, and County Councillor

School safe crossing – parents of children at the primary school would like crossing the road to the school made safer, they are very concerned about the amount of traffic, especially those who park cars along the roads in front of the school and locally, the speed of traffic, the flashing signs and signage etc.

The parish council arranged a meeting with Highways so that the spokesperson could discuss the problems and ask for assistance to improve the situation.

Flashing signs, these used to be turned on and off by someone from the school, it has been found the signs are broken, school to repair.

Lollipop lady – when the last lollipop lady left the role it was considered unnecessary by NCC to replace them. Insurance requirements mean that this is a paid job from NCC and not something volunteers/parents can undertake.

Signage needs cleaning – Highways no longer clean signs, parent proposed to clean these signs themselves. 30mph roundalls on the road – Highways have put these on the list to be done.

Highways are to ask a colleague to visit the primary school at drop off and pick up time to ascertain whether a road traffic survey is required, the cost for this is £5k but if there are any traffic calming schemes which could be applied the cost might be able to be offset off the cost of the scheme, the Clerk is checking this, possibly using the Parish Partnership Scheme, applications are closed until later in the year with the parish council paying 50% and NCC paying 50% of the costs for any project.

A Community Speedwatch Group could be set up to monitor speed but ideally would need to cover other areas on the parish as well.

The SAMs2 unit – the parish council are discussing with Highways where the unit could be sited near the primary school, this would be to obtain speeds and volume of traffic at different times of the day, waiting for Highways to reply, the Clerk will chase them again.

Plot of land for sale at the top of Hythe Road, approx. 30 acres residents may want to look at the details online as this looks like it could become a site for development.

Can there be row of coat hooks for those using the Fenton Room kitchen and 21 Room kitchen – to MHCCT.

Cllr. Ryves – very good debate regarding the defib for Brookville, different viewpoints.

Elections are in May for those interested in joining the parish council.

The UK Shared Prosperity Fund and Rural England Prosperity Fund have in excess of £3 million to invest in projects to support communities and businesses planned by the Borough Council, applications for funding will open soon, see link below.

The county's libraries are also able to offer some help with the process, including free access to public computers and WIFI, at any time that the library is open. They can also give people one-to-one support to go through the process by appointment.

At libraries voters will need to take their National Insurance number and, importantly, their own device that can be used to take and upload a photograph, even if they are going to the library for support. If visiting a library for help voters should check local opening times and make an appointment if one-to-one help is needed.

If you do not have internet access, call 01553 616200 for a paper form to apply for a Voter Authority Certificate or to request a postal vote.
