- 5.3 Open Spaces Working Party No meeting held in December but rec. mats are in need of power washing, replacement safety surfaces are still being investigated and best option sought. Cranwich Road several accidents due to it not being gritted, Clerk has reported to NCC & Highways and Cllr. Storey to follow up.
- Hall & General Purposes Working Party No meeting held in January 2018. Request from people who organise the Pilgrims walk every year on the run up to Easter to use the Fenton Room for a stopover, historically they have never been charged for this but the Parish Council reserve the right to charge for cleaning. BH proposed that the Pilgrims are allowed to continue to use the Fenton Room for their stopover, CW seconded All Agreed Methwold Community Action Group use St Georges Hall for the community event 'Carols around the Christmas Tree' they have requested a reduction in the hire cost, there was a discussion K Plumridge proposed that the hire fee is waivered as this is a community event and free to all who attend, S Burbridge seconded D Thomas and R Gibson abstained as they are on MCAG committee remaining Councillors agreed to waiver charges. Clerk to inform MCAG. The next Methwold Theatre Club production 1st night clashes with the April Parish Council meeting, would the Parish Council consider moving to the Fenton Room for this date? All agreed to this.

The heating in the 21 Room has caused the floor to move, P Crawley will investigate and resolve.

The bricks on the front of St Georges Hall are spalling, this is getting worse and needs attention, this will be taken to the Hall group for discussion and quotes received and approved for when the weather is improved.

A sign is required on the end of the old social club, mock ups were shown and the council discussed, The Chairman opened the discussion up to the public, this will go to the next Hall meeting for discussion at the February Parish Council meeting.

The breaker alarm on the door which separates Mini Methwold and the youth room is required please, D Thomas will do this as soon as possible.

Hole in the floor of the Fenton Room near the folding doors JM/DT to investigate

The light in the ladies toilet in the old social club is flashing.

Car abandoned on High Street, Mercedes Vito – DVLA has this listed as a Fiat Police have been informed but not done anything, Clerk to report to BCKLWN

11. To pass a resolution to exclude members of the public – Fire Alarm System Quotes

The original old social club fire alarm system is not big enough to cope with the size of the whole building and zones required to be covered and requires updating, quotes have been requested and two have been received. The Chairman went through the quotes and explained the requirements to comply with Fire Regulations.

Quote A £9090 Quote B £6817 these quotes are for exactly the same level of detection and sound bases same conditions. R Gibson proposed Quote B is accepted Seconded by K Plumridge All agreed.

The fire escape lights, signs and fire doors are to be dealt with and quoted for separately.
