**Summary of my recommendations:**

All documents viewed, relating to council practices were in very good order, as at the last internal audit.

A comprehensive risk assessment has been carried out by committee. This should be presented to the full council at a full council meeting and the minutes of the meeting should indicate that the review has been carried out and the results presented to the full council.

The duties of the RFO are contained in the Parish Clerk's contract of employment. RFO duties should also be contained in Council standing orders – preferably the financial standing orders.

The Parish Council owns its own website (the previous site was privately owned), that has recently become live. The new site is excellent – simple to navigate and containing, at the time of this audit, all the information required by statute. The site meets the tests for accessibility, that is, perceivable, operable, understandable and robust. All this indicates excellent work by the Parish Clerk and the person who set up the site.

I recommend that, subject to the approval of council, the following items of information be placed on the site for the benefit and information of residents:

- The Parish Council is the Burial Authority and it would be useful to display on the site a list of charges, cemetery rules etc. Persons requiring this information would almost certainly expect it to be available on the Parish Council website.
- The asset list, including current values should be on the website. This is, of course, a statutory requirement for councils with a turnover under £25k. I would urge that this practice be followed by Methwold Parish Council. This would inform residents of the value of much of the equipment owned by the council.
